Meeting Minutes for March 8, 2022: Sandy made a <u>Motion</u> to approve the minutes for March, Colleen seconded, *motion carried*..

Treasurer report:

Financial Report distributed by email on 4/10 by Malissa.

- Mar 2022 balances: Foundation: \$15,514.73. Total with clubs / sports / grad night: \$105,536.94
- The large increase is due to \$26k deposited for grad night

Rummage Sale: Jason reports rummage sale made \$160 in table fees, plus \$83 between donations, Colleen's lemonade stand and Alejandra's garage sale. Handed out 60 Senior yard signs.
